Simply follow these instructions to set up your account and sign up for eDelivery of your statements, confirmations and more.

Five easy steps to enroll

1. Visit the Wealhscape Investor login page at <https://www.WealhscapeInvestor.com/associated> and click the "Register Now" link.

2. Type in the last four digits of your social security number along with your first and last name, and date of birth.

4. Create a password following the Password Guidelines. You will then be prompted to create a security question.

3. Enter your valid brokerage account number, which can be found on the NFS Welcome Letter as well as your first NFS brokerage statement. You may also contact your Associated Bank Financial Consultant or the Associated Guidance Center at 800-595-7722, Monday through Friday, 8 a.m. to 5 p.m. CST.
